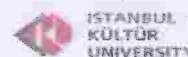

D LEMGO 01

- Final projects need to be approved by a supervising professor.
- Exchange students will meet the admission requirements of the host university in terms of prerequisites for courses and language proficiency.
- Exchange students will be admitted as full time, non-graduating students at the host university.
- The host university will provide guidelines for orientation for incoming students before and after the arrival.
- Exchange students are entitled to the same rights and privileges as students normally enrolled at the host university, except for the right for graduation.

2. The receiving institution will send its decision within 2 weeks.
3. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI. [It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]
4. Termination of the agreement

[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]


