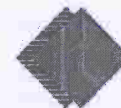

The partners commit to amend the table above in case of changes in the mobility data by no later than the end of January in the preceding academic year.


