2. The receiving institution will send its decision within 2 weeks.

3. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI. [It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]

4. Termination of the agreement.

[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]

ECTS Grade	Bulgarian Grade	Definition
A- Excellent	6	EXCELLENT - outstanding performance with only minor errors
B - Very good	5	VERY GOOD- above the average standard but with some errors
C- Good	4	GOOD - generally sound work with a number of notable errors
D, E-pass	3	SATISFACTORY - fair but with significant shortcomings / SUFFICIENT - performance meets the minimum criteria
FX- fail	2	FAIL - some more work required before the credit can be awarded
F - fail	2	FAIL - considerable further work is required

ECTS credits:

- 1 full academic year (2S) should have 60 credit points
- 1 semester should have 30 credit points
- 1 ECTS credit point corresponds to 30 hours (lectures+seminars+homework)
